### To our Exhibitors, Parents, 4-H Leaders and FFA Advisors

#### "What's New"

- Beef New minimum weight of 1,100 and a maximum of 1,400 to align with industry standards.
- Beef New slick show class.
- New Cavie Division
- Swine Pay on max weight of 280 per pound
- Dairy Goat Show moved to Saturday, May 31<sup>st</sup> at 9:00 a.m.
- Goats
  - No pronged or spiked collars allowed.
  - Goats must be dehorned or horns tipped with blunt ends (flat and have to point) and less than 2 inches in length.
  - Goats must be slick-shorn with 3/8 inch of hair or less above the knee or hock joints upon arrival at the fair.
  - o No substances may used on the goat's rectum area to cause the tail to remain erect.
- Horse Show New Ranch Riding Class
- Sheep No halters or chains during the weigh-in
- Selling requirement—If you wish not to sell, you must withdraw from the sale within one hour after the show.
- Exhibit Installation Hours
  - o 1:00 p.m. to 9:00 p.m. on Saturday, May 31st
  - o 6:00 a.m. to 9:00 p.m. on Sunday, June 1st
  - o 5:00 a.m. to 7:00 a.m. on Monday, June 2<sup>nd</sup>
- Application and interview process for Outstanding Exhibitor.
- Auction checks will be released to the 4-H Club Leaders and FFA Advisors on Monday,
- June 30, 2025, to allow buyers enough time to pay their auction bills.

All entries must be completed online. All required documents must be uploaded into the entries. Please follow the online instructions at www.mercedcountyfair.com.

#### Entry Closing Deadline is Thursday, May 1, 2025

We have had exhibitors who missed this MOST IMPORTANT deadline and were disqualified from participating each year. It is heartbreaking and expensive, but our local rules clearly state **late** entries will not be accepted, no exceptions".

To further explain, in the 2024 State Rules for California Fairs, under Eligibility II, 3. "No entry form or entry will be accepted after the closing date for entries." Also, in the Preface, item 3. "These rules cannot be waived or amended by anyone, including the fair board, management, or the judge."

We are <u>not</u> able to accept late entry under any circumstance. To avoid any pitfalls to entering, below are just a few tips to help you with the process:

- Don't forget to enter online by Thursday, May 1, 2025.
- It is suggested that you submit your online entry sooner rather than later.

- Please don't wait until 10:00 pm, the night it is due, because if something goes wrong, such
  as your computer failing, a power outage, or your credit card charge not going through, we
  cannot help you.
- The system will automatically shut off at 11:59 p.m. on May 1, 2025, and will not let you in, so again, please don't wait until the eleventh hour.
- After entering online, you will receive a confirmation e-mail and a receipt. Print your receipt and check your entries. Make sure you have showmanship class and breeding or market. If you don't receive your confirmation e-mail, the entry process is incomplete, and you are not entered.
- If you entered the DHR Program by its February 5, 2025 deadline, REMEMBER that you must also enter your Dairy Heifer into the fair in the online portal. It is a two-step process.
- When entering your animal, don't forget to enter showmanship.

We want everyone to be able to participate, but the exhibitors and parents are responsible for their part. Let's make 2025 the year of no disqualifications!

#### MERCED COUNTY FAIR EXHIBITOR CODE OF CONDUCT

Exhibiting livestock at the Merced County Fair is a privilege and must be respected as such. To that end, all junior exhibitors who wish to sell and/or show at the Merced County Fair must adhere to the Code of Conduct to be eligible to participate at the Fair. This Code of Conduct covers the conduct of the exhibitor from the Sunday before the opening day of the fair through Sunday, the last day of the fair. Violations of the Code of Conduct will not be tolerated. An investigation of alleged violations will be conducted, and a decision rendered by the appropriate involved parties according to the Code of Conduct protocol. Violations may result in loss of premium, awards, and/or the right to sell animal(s) at the auction.

- Exhibitors will refrain from any use of alcohol, drugs, vaping, or tobacco during the Merced County Fair.
- Exhibitors may not use obscene or discriminatory language.
- Exhibitors are to be good citizens by helping those around them have positive experiences.
- Exhibitors are to demonstrate caring for people other than themselves. Know that harassment of any type is illegal and prohibited.
- Exhibitors must practice good sportsmanship behavior.
- Exhibitors will treat their animals safely and kindly. Animals will have the necessary feed and water the entire time they are at the fairgrounds.
- Exhibitors will always keep their animal pens clean and free of hazards.
- Exhibitors will treat adults, especially those in authority, with respect.
- Exhibitors will follow all State and Local rules that apply to your particular project(s)
- Exhibitors shall fit and groom their own animals for the show. Exhibitors may receive *limited assistance* from their parents, guardians, other exhibitors, Leaders, and Advisors.
- If Exhibitors are staying in the fair camping area, or visiting friends in the fair camping area, you will abide by all curfews and other camping area rules.

#### MERCED COUNTY FAIR PARENT/GUARDIAN CODE OF CONDUCT

As a parent of a Livestock Exhibitor at the Merced County Fair, you are expected to adhere to the following Code of Conduct. Failure to do so will jeopardize the participation of your child, or family member.

- The livestock show and sale is an educational experience for your child and as such, exhibitors shall fit and groom their own animals for the show. Exhibitors may receive *limited assistance* from their parents, guardians, other exhibitors, Leaders, and Advisors. No Professional Fitters.
- As a parent/guardian, you acknowledge that direct criticism or interference with the judge, show management, other exhibitors, breed representatives, auctioneer, or show officials before, during, or after the competitive event is prohibited. All judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation, and respect and as a parent/guardian, I will not allow any person connected with my child's animal project to direct abusive or threatening conduct toward any show official.
- Parents/guardians shall champion equality and respect the rights, dignity, and worth of all people involved in the Merced
  County Fair livestock program, regardless of gender, race, marital status, color, disability, sexuality, age, occupation,
  religion, or political opinion.
- Parents/guardians should use respectful language. No foul or abusive language or gestures shall be directed toward a judge or staff member at any time. Such conduct will not be tolerated.
- Parents/guardians should limit their use of alcohol in the barns to set a proper example for their child and the children of others.
- Parents/guardians shall not provide alcohol to anyone under 21 years of age.
- Parents/guardians shall not have any alcohol in a child's showbox in the barns.
- Parents/guardians shall not use any drugs that are considered illegal while on the grounds.
- There is no smoking or vaping permitted in or near the barns.
- I will follow the procedure and chain of command if there is a conflict.

Final Decision: Fair CEO and/or Board of Directors, and/or Division of Fairs & Expositions

Violation: Auction Rules

Report to: Livestock Superintendent Final Decision: Auction Executive Committee

- All alleged violations will be reported in writing to the Livestock or Fair Office. No oral complaints will be investigated unless reported by fair security staff to Fair Management.
- Witnesses to the alleged violations will be contacted and interviewed. For Code of Conduct violations, witnesses may be asked to appear before the Board of Directors in front of the accused. It is in the sole discretion of the Board of Directors whether to hold a hearing.
- All decisions made by the Fair CEO regarding the RV Park may be forwarded to the Merced County Fair
  Board of Directors at their next meeting. To be placed on the agenda, contact the fair office immediately to
  meet the State of California open meeting notification requirements.
- Concerns regarding the board's decisions may be forwarded to the Merced Fair Board of Directors at their next meeting. To be placed on the agenda, contact the fair office immediately to meet the State of California open meeting notification requirements.
- All decisions by the Junior Livestock Auction Committee are final. Concerns regarding the committee's
  decisions may be forwarded to the full 35<sup>th</sup> District Agricultural Association, Merced County Fair Junior
  Livestock Auction Committee for their next regular meeting.
- All judge's decisions are final and cannot be protested.

#### **LOCAL RULES**

- All State Rules for California Fairs apply. A copy of the State Rules for California Fairs may be obtained at <a href="https://www.cdfa.ca.gov/fe/">www.cdfa.ca.gov/fe/</a>
- 2. <u>All entries must</u> be properly made online at <u>www.mercedcountyfair.com</u>.
- 3. **CLOSING DATES**: The management reserves the right to close a class before closing date in the event that all available space has been allotted or to extend closing date, by Board approval, if, prior to closing date, sufficient entries for proper competition have not been received.
- 4. All entries will be under the direction of the superintendent of the livestock department. The fair management will not be responsible for any loss or damage that may occur.
- 5. All entries are entered at the exhibitor's risk.
- 6. Under no circumstances will a judge award a prize for any entry that does not merit such an award. This applies whether there are one or more entries in the class.
- There must be two or more exhibitors in a division to qualify for "best in division" awards.
- 8. The State Rules, Species Rules, Health Rules and Judging Standards as prescribed by the Fairs and Expositions Branch and published in a separate booklet available at the fair office apply to all entries of this livestock show & sale.
- 9. Unless otherwise noted, entries are limited to residents of Merced County
- 10. The Livestock Superintendent will act in the best interest of the Animal Exhibit, Exhibitor, and the Fair.
- 11. Weather conditions may dictate changes in the livestock department. Haul-in times, Haul out, Show schedules, and Weigh-in times may be altered or changed in order to accommodate excessive heat.

# LOCAL LIVESTOCK RULES AND INFORMATION

A copy of the 2025 State Rules may be obtained at <a href="https://www.cdfa.ca.gov/fe/">www.cdfa.ca.gov/fe/</a>

All local rules apply.

**GENERAL:** All livestock will be under the direction of the livestock superintendent. Fair Management will in no case be responsible for any loss or damage that may occur. Each exhibitor or their representative will be solely responsible for consequential or other loss, injury or damage to, or occasioned by or arising from an animal exhibited by him and for its description, as given in the premium list; shall indemnify the ASSOCIATION against all legal or other proceedings thereto.

**EXHIBITS:** No animal shall be admitted or remain on the grounds that show any evidence of any communicable disease or unsightly condition. This may include but is not limited to; caseous lymphadenitis (CL), ringworm, club lamb fungus, contagious ecthyma (sore mouth), and prolapsed or open wounds. All exhibits must remain on display for the duration of the livestock show and sale and may be removed only with the written permission of the Fair management. If an entry is removed without a release form, that exhibitor will forfeit all premiums and sale proceeds and may be subject to further disciplinary action. All milking cows and milking goats will be released at the completion of their respective shows. A release must be obtained from the livestock office before the animal can be removed from the fairgrounds.

**CLEANING OF BARN AREA:** Animals, pens, and stalls must be kept groomed and in show condition at all times. Due to water conservation measures, Fair management may greatly curtail the use of water. Including but not limited to washing, cooling, and other water use in the Livestock area. Nozzles are required on all hoses.

No premiums will be paid on any market animals.

<u>POST/LATE ENTRIES</u>: No late entries will be accepted, and **no exceptions**.

Entry Closing Date: Entries and fees are due online only on or before May 1st by 11:59 p.m. If you don't receive an e-mail confirmation, you are not entered, and it means you did not complete the entry process. Be

sure to check your Spam folder as well; depending on your security, it may view this program as spam.

#### **Eligibility and Age Requirements:**

**FFA Members -** Limited to students in Merced County High Schools unless otherwise noted. FFA members may participate as members until the end of the calendar year following the year of graduation from high school.

**4-H Members** - Limited to 4-H Clubs located in Merced County. 4-H members may enroll if they are 9 years old by December 31, 2024, and can exhibit as a member until the end of the calendar year in which they reach age 19. Second and third graders, officially enrolled in 4-H, may exhibit in special divisions designated for 4-H Primary-Members.

Independent Junior Exhibitors - Limited to residents of Merced County, unless otherwise noted, who are not members of FFA or 4-H unless otherwise noted, exhibitors must be at least nine (9) years old by January 1, 2025. Exhibitors are eligible to compete/exhibit through December 31 of the year in which they turn 19 years of age. Independent junior exhibitors must enter an open junior class unless one is not available. If open junior classes are not available, junior exhibitors may enter appropriate FFA or 4-H classes if they meet all appropriate age and State Rule requirements.

Independent Junior Exhibitors in the Livestock **Department** will compete in appropriate Divisions based on school grade level completed. Eligible Independent exhibitors who have completed 3rd-grade through 8thgrade graduation will compete within the 4-H Divisions. Exhibitors who graduated from 8th grade through 12th grade will compete within the FFA Divisions. Exhibitors must complete and file with the Fair the Independent Junior Livestock Exhibitor Packet which includes supplying the Fair with a copy of their birth certificate or driver's license, purchasing liability insurance (Large Livestock) and providing the Fair with a picture of their animal, appropriate proof of ownership, permanent tag, tattoo and/or hog ear notch information 120 days prior to the fair for market beef & dairy replacement heifer. 60 days for all breeding species, market sheep, market swine, market goats, rabbit, cavy & poultry entries. An FFA or 4-H member may exhibit as an independent junior if that exhibitor is not enrolled in an FFA or 4-H project within 60 days (120 Market beef & Dairy replacement heifer) prior to the livestock show and sale. Check with the fair office for deadlines and forms.

<u>Uniform Requirements</u>: When showing, FFA exhibitors will be required to wear the official FFA show uniform. For 4-H exhibitors, it is required that white pants, a plain white shirt with a collar (short or long sleeve), and a tie/scarf be worn. The 4-H hat is optional. The 4-H green jacket will not be allowed for showing as it is not part of the official uniform. For Independent Junior exhibitors, it is required

that white pants and a white dress shirt (short or long sleeve) be worn. For <u>all</u> exhibitors, no bare midriffs or flip-flops are allowed.

Animal Health Issues: Animals identified by fair management as having a potentially contagious disease may be required to leave the grounds immediately. As animal health issues arise, various health tests or proof of animal health may be required before animals are brought onto the grounds. Fair management will notify leaders and advisors if such testing should become necessary.

In the State Rules, X., Eligibility 1., Per State Rule X. Eligibility, 1., Any inhumane activity to animals by the exhibitor, as determined by fair management in consultation with the fair veterinarian, may cause disqualification, forfeiture of awards, and removal of the exhibit from the fairgrounds.

<u>Awards Ceremony</u>: For exhibitors receiving awards, please sit in the chairs closest to the presentation area so as not to delay the program. All exhibitors should wear the appropriate dress when receiving an award.

**Barn Space:** Pens, stalls, and livestock must be kept thoroughly groomed, clean, and in show condition at all times. Exhibitors must supply their own equipment in caring for animals. Entry fees *do not* guarantee tie space or pens. Management reserves the right to reassign barn space based on the number of animals brought to the fair. No water troughs are permitted on fairgrounds.

**Brand Inspections:** All beef and dairy sale cattle must have a brand inspection 120 days prior to the fair except for animals raised by the exhibitor through his/her own breeding project. Brand inspection certificates must be surrendered upon arrival at the fair.

<u>Clean Barn Awards</u>: Clean barn will be given to the outstanding 4-H Club and FFA Chapter for the neatest and cleanest barn areas maintained throughout the duration of the fair. Judging will take place daily.

<u>Dogs/Pets</u>: No pet dogs are permitted on fairgrounds, except service animals.

Entry Limits: Exhibitors are limited to a maximum of 10 animals, including market entries. Registered sheep exhibitors are limited to a maximum of 14 animals, including market and feeder entries. Exhibitors may not show more animals than they are able to care for personally. Exhibitors are limited to two entries per class in divisions where the breed is specified. In the "All Other Breeds" and "All Breeds Judged as One" divisions, two entries per class per breed will be accepted.

**Exhibit Installation:** Stall decorations must not block airflow in the barns. The Exhibitors must have their exhibits in place by 7:00 a.m. Monday, June 2nd.

Decorating stalls may start Saturday, May 31st, at 1:00 p.m. until 9:00 p.m.

Large livestock receiving will be Sunday, June 1st, from 6:00 a.m. until 9:00 p.m. and resume Monday, June 2nd, at 5:00 a.m. until 7:00 a.m. The livestock must be in place by 7:00 a.m. weigh-in. A fee of \$25.00 per animal per day will be charged for any livestock brought onto the fairgrounds prior to 6:00 a.m. on Sunday, June 1st.

Exhibitor Showing & Selling: Exhibitors must be present at show & sale rings when their animals are shown/sold or the animal will be disqualified. Exception requests must be in writing and presented to the Livestock Superintendent for the Board of Director's determination by Friday, May 30 at 5:00 p.m. Exceptions include attending a funeral, their own or sibling's graduation, injury, or participating in a school-related sports activity. Participating in a city league or traveling sports team does not qualify.

<u>Grooming & Fitting:</u> The livestock show & sale is an educational experience, and as such, exhibitors *shall* fit and groom their own animals for the show. Exhibitors may receive *limited assistance* from their parents, other exhibitors, Leaders and/or Advisors. No professional fitters.

**NOTE:** Violation of this rule will result in disqualification of the exhibitor and exhibit, forfeiting all awards, premiums, and eligibility to participate in the auction. All cattle must be shown on leather show halters.

**Fitting Areas:** The fitting area on the north side of the sheep barn will be marketed and designated to chapters and clubs. For bio-security safety measures, species must stay within their species areas for fitting, i.e., Sheep/goats are not allowed in the Beef/Dairy barn.

Loss or Injury: Exhibitors will always give the necessary and personal attention to whatever they have on exhibit. Each exhibitor, or his representative, will be solely responsible for any loss, injury, or damage caused by any animal exhibited by him and shall hold the Association and its agents harmless and indemnify them against any legal proceedings arising from such loss, injury or damage.

<u>Market Entry Limit</u>: Exhibitors are limited to one market or feeder entry per species.

#### **Market Weight Minimum:**

Beef	1,100 pounds
Swine	200 pounds
Sheep	100 pounds
Goats	60 pounds

<u>Sale Weight Maximum:</u> For sale purposes, payment will be made on maximum weights as follows:

Beef 1,400 pounds Swine 280 pounds Sheep 150 pounds Goats 105 pounds

<u>Outstanding Exhibitors</u>: Awards will be presented to the Outstanding Beef, Boer Goat, Dairy Goat, Sheep, Swine, Rabbit, and Poultry Exhibitors in both 4-H and FFA and will be determined by the total amount of premium money won. Premiums won on a maximum of 5 animals only will be considered.

Ownership Requirements: Livestock projects must be owned by and under the exhibitor's care and management and under the supervision of the organization in which the project will be shown as follows: 30 consecutive days for all breeding species, feeder, market rabbits, and market poultry; 60 consecutive days for market swine, sheep, and goats; 120 consecutive days for market beef and dairy replacement heifers. The official ownership date is the date shown on the Bill of Sale unless the exhibitor bred the animal. The days are counted prior to the opening day of the livestock show & sale.

<u>Ownership</u>: No livestock owned solely by a chapter or club, or conducted as a joint project by two or more individuals, is eligible. No partnerships.

#### **Proposition 12 Certificates:**

Prop 12 Certificates are required for all market hogs that are entered. Exemption certificates will also be required for 4-H/FFA raised and sold market hogs. Certificate upload required at time of entry.

Parking - Exhibitor: The "G" Street Parking Lot provides parking for exhibitors and their families. The parking permit must be visible, or the vehicle will NOT be admitted to the "G" Street parking area. Exhibitors may drive their vehicles containing necessary feed or bedding onto the fairgrounds to care for and feed their animals between 5:00 a.m. and 7:30 a.m., Monday through Saturday. Please off-load and remove your vehicle from the preferred parking or the employee/judges parking lot (next to the dairy barn) by 7:30 a.m. or risk being towed.

<u>Preferred Parking</u>: The preferred parking pass is for parking only. It does not include admission to the Fair. Preferred parking with in/out privileges begins Monday, June 2<sup>nd</sup>, through Sunday, June 8<sup>th</sup>. Permits are transferrable. Permits are required to park in the onground lot. Vehicles are limited to passenger vehicles and trucks; no RVs. Permits must be properly posted, as vehicle towing will be enforced.

Pass Policy: The following policy will be enforced: "Any person using or distributing counterfeit credential(s) (admission pass, wristband or parking pass) may be subject to removal from the fairgrounds and/or exhibit removed and/or all premiums forfeited. Any person utilizing, distributing, or selling counterfeit credential(s) may be prosecuted to the full extent of the law. The use of non-authorized credentials is a theft of state funds.

<u>Passes - Exhibitor</u>: Each exhibitor will receive a wristband and one "G" Street parking permit, good for one admission per day for the five days of the fair. If the wristband breaks, the broken one must be returned to the livestock office for a replacement wristband.

<u>Passes - Parent</u>: Because of limited space in the livestock office, we will no longer sell parent passes at that location. Pre-Sale Admission and Carnival Pre-Sale may be purchased from the Administration Office "Box Office" in front of the fairgrounds on MLK Jr. Way. Monday, June 2<sup>nd</sup>, and Tuesday, June 3<sup>rd</sup>, from 8:00 a.m. to 5:00 p.m.

The Livestock gate will operate as paid admission on a 24-hour basis beginning Wednesday, June 4<sup>th</sup> at 8:00 a.m.

<u>Passes—4-H Leader</u>: 4-H Community Leaders will receive two leader wristbands per species for admission into the livestock show and sale and a G Street Parking Permit for them and each large animal species exhibited by the 4-H Club. The community leader will distribute the leaders' passes.

<u>Passes - FFA Advisor</u>: FFA Advisors for livestock entries will receive one "G" Street Parking Pass and a wristband for one admission per day for the five days of the fair.

<u>Pop-up Tents</u>: Per the State Fire Marshal, no pop-up tents are allowed in the barn areas during the livestock show & sale. This is due to safety concerns and the need to maintain emergency vehicle access around the barns.

<u>Generators</u>: Per the State Fire Marshal, Generators cannot be stored or operated in the barns at any time. Generators must be 20 feet away from the Barn. First violation: the exhibitor will be asked to remove the generator from the barn. Second violation exhibitors will be asked to remove the generator from the fairgrounds.

<u>Coolers and Port-A-Coolers</u>: During excessive heat, port-a-cools may be used in the barns. Depending on the electrical load, clubs may need to limit themselves to one cooler per club/chapter.

**<u>Premiums:</u>** No premiums paid on market animals.

<u>Pro-lapse</u> - Market lambs exhibiting signs of pro-lapse, or noticeable repair to a pro-lapse, will be excused from the show and fairgrounds at the direction of the management.

Registered Animals: All animals in *the* "Registered Purebred Breeding Animal" Divisions must be registered and recorded with a United States (U.S.) Breed Association in the exact name of the exhibitor (owner) as declared on the entry form (see State Rules for exceptions). All registered animals are subject to tattoo and registration identification checks by fair management.

Release of Tack or Animal: Release of tack and large breeding animals will be permitted on Sunday after 5:00 a.m., June 8<sup>th</sup>. Regarding the final clean-out, Beef & Dairy exhibitors must pull their bedding/manure back one foot from the tie rail. Sheep exhibitors move bedding/manure to the East side of the barn. Swine exhibitors are to move their bedding to dirt area behind the milk barn before dismissal.

#### Release of Animals to the Buyers

**Beef Heifers**—For traffic safety reasons, the new owner may remove Beef-Bred Heifers sold through the sale on Wednesday, June 4<sup>th</sup>, after the sale or Thursday, June 5th, from 7:00 a.m. to 2:00 p.m. MMCA will monitor the release and provide a release slip to the purchaser.

**Dairy Heifer Replacements**—For traffic and safety reasons, the buyers may remove Dairy Heifer Replacements sold through the sale on Sunday, June 8<sup>th</sup> from 10:00 a.m. to 2:00 p.m. only. The payment receipt and transport slip may be obtained after the sale from the Livestock Office before leaving the grounds.

Final clean-out - Exhibitors in the Beef & Dairy barns are to pull their bedding/manure back one foot from tie rail. Exhibitors in the Sheep barn are to move bedding/manure to East side of barn. Exhibitors in the Swine barn are to move their bedding to dirt area behind the milk barn. Exhibitors in the Glacier Pavilion can leave their bedding in the pens. Dairy Heifer Replacements sold through the sale may be removed by the new owner after the completion of the sale after their purchases have been paid. Market Rabbits & Poultry may be removed after the completion of the sale and their purchases have been paid for.

#### Ropes & Lassos

Ropes/lassos are not allowed on the grounds to be played with to prevent the spooking of animals and for everyone's safety.

**RV Camping:** Trailer registration begins April 1st for \$150.00 per trailer. The RV lot will be the fairground "G Street lot". Registration forms are available at the fair office and online. Trailers <u>MUST</u> be brought in on Saturday, June 1<sup>st,</sup> and Sunday, June 2<sup>nd,</sup> between the hours of 7:00 a.m. and 5 p.m. Trailers failing to be in place on these dates will forfeit fees and not be admitted. No trailers will be permitted in the campgrounds before 7:00 a.m. on Saturday. All trailers must enter through the "G"

Street campground gate and must be registered with the livestock office. Trailers must be removed from the G Street campground by 5:00 p.m. Monday, June 9<sup>th</sup>.

Scrapie - Scrapie tags are mandatory for sheep and All sheep and goats require individual goats: identification. All official identification will be kept on the animals. The official identification may be official USDA individual identification ear tags, premises ear tags or legible premises tattoos (if they include a unique animal number), Scrapie Flock Certification Program ear tags, legible registration tattoos if accompanied by registration papers, or other methods approved by the California Department of Food and Agriculture. See State Rules for additional requirements. All animals on the fairgrounds are subject to blood testing by the state. Sale checks and/or premiums may be withheld pending blood test results. In cooperation with the USDA Wholesome Meat Act and to ensure the nation's food supply, all livestock are subject to drug testing for Quality Assurance.

<u>Selling and Showing at Auctions</u>: Exhibitors may sell in two of the following four areas:

- 1) Dairy Heifer Replacement Sale
- 2) Beef Bred Heifer Sale
- 3) Small Animal Sale (rabbit & poultry)
- 4) Jr Livestock Sale (beef, swine, sheep, goats)

Exhibitors who do not want to sell a market animal that qualifies for a sale must notify the livestock office no later than 30 minutes after that species show's completion.

<u>Showing of Animals:</u> Exhibitors must show their own animals, unless they have more than one animal in a class.

<u>State Rules</u>: State Rules, Species Rules, Health Rules, and Judging Standards as prescribed by the Branch of Fairs and Expositions and published in a separate booklet available online

https://www.cdfa.ca.gov/FairsAndExpositions/Fair\_Information/State\_Rules\_for\_California\_Fairs.aspapply to all entries of this fair.

**<u>TB Testing</u>** - TB testing is not required for dairy cattle.

<u>Vehicles on the Grounds</u> Because of State Fire Marshal regulations, all trucks, trailers, and cars must be parked in the spaces provided. No vehicles may be parked between or behind the barns, buildings or on fairgrounds streets. Unload and move your vehicle to the parking areas.

<u>Washing of Livestock</u>: A nozzle with an automatic shutoff must be used. Absolutely no free flow of water will be allowed.

<u>Weigh-in</u>: Market livestock entered by division number only will be entered in the proper classes by the livestock entry clerk in accordance with the weight of each animal and breed called at scale. Weigh-in will begin Monday, June 3<sup>rd</sup> as follows:

Swine 7:00 a.m. Order to be posted
Sheep 8:00 a.m. Order to be posted
Goats Follows Sheep Order to be posted

Beef 9:00 a.m.

For the health and safety of the animal, load-in and weighin times are subject to change if weather conditions dictate.

Market and feeder lambs & goats must be slick shorn with 3/8 inch of hair or less above the knee or hock joints before entering the scale. Sheep will be checked at the weigh-in for 1/4" of stretched fleece. Lambs & goats not meeting this requirement will not be weighed for showing until the rule is complied with. No halters or chains allowed on the sheep while weighing in. No portable scales are permitted on the grounds. Animals will be inspected before being allowed to enter the scale area. If a vet is not present during weigh-in of any animal suspected of a communicable disease or unsightly condition will not be weighed until inspected by a veterinarian. As stated in State Rules, the Veterinarian's decision is final.

**Re-Weigh Policy:** If an exhibitor wants to re-weigh their animal, it must be requested while the animal is at the scale. The animal will be removed from the scale, the scale zeroed, and then immediately placed back on the scale. There will be no other re-weigh once the animal has left the scale area.

Youth for The Quality Care of Animals: The California Department of Food & Agriculture (CDFA) is requiring all youth livestock participants (excluding horses, cavies, & dogs) 9 years of age and older to obtain annual certification in the Youth for the Quality Care of Animals (YQCA) program. Those not certified will not be able to participate at a California Fair. To comply, Merced County Fair is requiring all exhibitors who fall under this rule to complete the training by Thursday, May 1<sup>st</sup>, 2025 (entry deadline). If you do not complete the training by 11:59 PM on May 2<sup>nd</sup> your entry will be considered ineligible, and you will be disqualified from exhibiting at the fair.

Training can be completed in two ways:

- Go to YQCA Program.org and complete the online course.
- 2) Attending and completing an in-person instructor lead course by a YQCA-approved instructor.

Your certificate number will be required to complete your online entries. You must also upload your YQCA Certificate during the online entry process. Certificates must be Valid through June 30, 2025. Please plan to take the course BEFORE you complete your entries. You will not be able to complete your entries without certification.

Please note if your certificate is expiring before our Fair, you must renew it prior to the entry deadline.

#### **Organization Sponsored Awards**

California Shorthorn Breeders Association will award prizes to the Outstanding 4-H or FFA Registered Shorthorn Exhibitors. Competition to run duration of fair. Selection to be based on the following: 1) Dollars Earned. 1 point per dollar earned in individual Registered Shorthorn classes. Top five animals per exhibitor to be considered for points. 2) Presentation in Show Ring. 25 bonus points may be earned based on the following: a) ability to present animals in the show ring and, b) showmanship and cooperation in show ring in individual and group classes. 3) Showmanship. 15 points for entering showmanship. An additional 10 points if placed in the final lineup of each showmanship division as recorded by fair management. 4) Good Housekeeping. 25 points for good housekeeping and presentation of exhibit in cattle barns. Emphasis will be given to those who perform their own work. Exhibitors will be given good housekeeping points. In the event of a tie, the committee will conduct interviews to decide the winner.

Merced County Holstein Association: awards for Outstanding 4-H and FFA Holstein Exhibitors. Competition to run the duration of fair. Selection to be based on the following: 1) Dollars Earned. 1 point per dollar earned in individual Registered Holstein classes only. No more than 1 can be a bull. Top five animals per exhibitor to be considered for points. Housekeeping. 25 points for good housekeeping and presentation of animals and exhibit in the barn, and in show ring for duration of fair. Emphasis will be given to those who perform their own work. 3) Showmanship. (Points earned in respective age groups only) 15 points for exhibiting in showmanship; then 5 additional points for placing in final "ribbon" lineup of your Showmanship division (4-H Novice, FFA Senior, etc.) as recorded by fair management; plus 1st place exhibitor in each respective division will get an additional 5 points; 2nd place, 4 points, down to 5th place who will get 1 extra point. No exhibitor can receive more than 25 total Showmanship points. 4) Sportsmanship, Attitude, Behavior and Interview may be included in deciding this award.

# 4-H AND FFA JUNIOR LIVESTOCK SALE

<u>Buyer Registration</u>: Buyer Registration table for the JLA sale will open at 8:30 a.m.

<u>Animal Criteria</u>: Animals exhibited at the Merced County livestock show & sale meeting the following criteria as defined in the 202 State Rules for California Fairs, may be sold:

Swine-Market Acceptable
Rabbits-Market Ready
Poultry-Market Ready

The Merced County Fair Livestock Show & Sale reserves the right to limit the number of animals to be sold. Exhibitors are limited to the sale of one large livestock (beef, goat, sheep, & swine) and on small livestock (rabbit & poultry) only unless awarded multiple champions listed below. All Fat Stock Champions must be terminal, with no live pick-up.

#### **Champions selling**

The fat stock Champions will start selling at Lot #251 immediately after the Buyer of the Year award presentation during Saturday's Junior Livestock Auction at approximately 12:30 PM.

<u>Sale Runners</u>: Each 4-H Club and FFA Chapter is responsible for providing runners. A time schedule and number of runners from each club/chapter will be

arranged by the Livestock Office. A runner schedule will be posted on the sale ring and the livestock office information board.

**Agent:** It shall be expressly understood that the 35th District Agricultural Association (Merced County Fair) acts only as an agent for the consignors and assumes no liability, legal or otherwise.

<u>Animal Disposition</u>: No animal purchased through the Livestock Sale or Small Animal Sale may be returned or given back to the exhibitor by the buyer. The disposition called by the auctioneer at the time of sale is final; **no changes can be allowed**.

<u>Animal Pickup</u>: Live pickup animals must be paid for and picked up at the conclusion of the sale.

**Buyer Accounts:** Buyers with outstanding accounts as of September 30, 2023, will not be eligible to purchase at the 2025 auctions.

#### **Overpayments**

Refunds of over-payments under \$10.00 will not be made.

**Buyer's Gifts:** Alcohol may not be given as part of any buyer's gift as it **conflicts** with the 35<sup>th</sup> District Agricultural Association's Alcohol Management Policy. The livestock office/sale staff will not supply exhibitors with the names of buyers during the Livestock auction.

#### Ice Chests/Show Boxes

Ice chests and show boxes may not contain alcohol when brought onto the grounds. Again, under our Alcohol Management Policy, no outside alcohol may be brought onto the grounds. Ice chests may be searched.

<u>Callipyge</u>: The processor will reject any market lamb found to contain the callipyge gene, and the seller will be responsible for the resale amount plus the slaughter fees.

<u>Auction Commission</u>: A 5.5% commission on beef, 6.5% on hogs, sheep, and goats, and 3.5% commission on market rabbits and poultry will be deducted from all sale checks.

#### What is the auction commission held from the Exhibitor's checks used for?

The CDFA, Division of Fair & Exposition's Accounting Procedures Manual states "The Auction Reserve account is the accumulated total of operations, that is, the net revenue from yearly auctions. The Board should specify minimum and maximum balances for this account. The minimum balance should be sufficient to cover bad debts and other unforeseen expenses. When the Auction Reserve exceeds its maximum, the board and the JLA

committee should develop a mutually agreed-upon plan to reduce the amount of the reserve by reducing the amount of commission to be withheld, or spending excess reserved on capital improvement to benefit the livestock program". Our Auction Committee and Board of Directors have chosen to use those reserves on capital improvements to benefit the livestock program. Below is a listing of items purchased over the last four years from the auction contingency funds.

We are so grateful to our buyers. Not only do they support the 4-H and FFA Exhibitors with their projects, but they also indirectly support the fairgrounds in making improvements to the Livestock facilities.

#### **Donation of Auction Proceeds:**

To be recognized at the auction block and announced that an Exhibitor is donating their auction proceeds, the Exhibitor must notify the Fair upon submitting their Entry by the entry closing deadline date. All net proceeds (100%), after deduction of the auction commission and fees, must be donated to the Exhibitor's charity of choice or special donation. Under no circumstances will the auctioneers announce any donation less than 100% net proceeds at the auction block. An Exhibitor may choose to donate less than 100%. However, it will be considered a "private" donation and not announced.

<u>Drug Presence or Residues</u>: Sellers are responsible for animals rejected at any processing center due to the presence of drug residues. The seller may be liable to the buyer for an amount equal to three times the purchase price and may also be liable for attorney's fees and civil penalties (Food and Ag Code Section 14363). All Market Exhibitors must sign a drug declaration statement prior to going across the scale.

#### Disposition of Animals through the Sales

**Process** - Have custom killed and fill your freezer. **Live Pickup** - Pick up live. Payment in full is required before the release of the animal.

**Resale-** Animal is automatically resold to a meat packer at market price and pay the difference.

How the resale works: If you buy a 120-pound lamb for: \$6.00 a pound

Sale Price \$720.00 Approximate Market Value \$.82 a pound

Market Value - \$96.00

Your donation

Billed amount \$624.00

The donation amount is what you would be billed. Figure the beef, hog, and goat the same way. Market prices will be posted on the day of the auction.

#### **Auction Buyer Admission**

The JLA Auction Committee recommended to the board of directors "sending <u>two</u> admission passes to each buyer who purchased an animal at the prior year's auction

### Recommendations to the Junior Livestock Auction or the Livestock Committee

Send a letter to the fair and put "Attention JLA Committee or Livestock Committee." Your correspondence will be reviewed during their annual meetings for consideration and recommendation to the Board of Directors. Ear tags: All animals must have ear tag information on their entries. Like last year, FFA Advisors and 4-H Leaders must email a list of exhibitors for each species to the Livestock Superintendent at Livestock@countyofmerced.com no later than March 24, 2025, to give ample time to prepare your packet. Ear tags will be dispersed to leaders, parents, and advisors starting April 15, 2025.

<u>Bills of Sale Upload Required:</u> A bill of sale for all species will be required for entries.

<u>Prop 12 Certificates</u> will be required for all Market Hog Exhibitors. Certificates must be uploaded at the time of entry.

**Exhibitor Selling:** Exhibitors must be present at sale ring when their animals are sold or the animal will be disqualified. Exceptions to this rule must be requested in writing from the Board of Directors by Friday, May 30th at 5:00 p.m

If an exhibitor misses their lot number, they are disqualified from the sale and will not be permitted to sell out of order.

#### **Exhibitor's Auction Checks**

Auction checks will be available for pick-up on **Monday**, **June 30**, **2025**, **by the FFA Advisors and 4-H Community Leaders.** This will allow enough time to process bump bids. Also, it gives the buyers ample time to review their auction statements to send in their payments for their purchases.

**Bump Bids** 

The Livestock office will begin taking bump bids once the sale catalogs have been released. This will allow the Buyers to fully complete the form with the needed lot numbers. Bump Bids for all auctions will remain open until 5:00 p.m. on Monday, June 9, 2025, to better serve our community partners and exhibitors.

**Exhibitors' Animal Responsibility:** Responsibility for livestock sold at the auction remains with the exhibitor until the transportation company moving the stock has it loaded aboard its trucks. Thereafter, responsibility will rest with the transportation company for safe delivery.

<u>Previously Shown Animal</u>: No exhibitor may show an animal that has been sold as a market animal through a fair junior livestock auction. whether there is an actual change of ownership or not.

<u>Selling Requirement:</u> All animals qualified for sale that are not properly pulled within one (1) hour of the completion of their show will be required to sell.

To be eligible to show and sell a market animal, all exhibitors must sign a sale contract at the time of entry. This signed contract is required for market entires to be accepted. Please visit our website to access the fillable sale contract documents. Once completed, scan and submit the signed contract along with your market entry. Only entries with a signed contract will be considered valid.

#### **Small Animals**

**Buyer Registration:** Buyer registration for the Small Animal Sale will begin at 5:30 p.m. on the evening of the sale.

**Disposition Options:** 

Rabbit: Live Pickup, Process or Resale Poultry: Live Pickup, Process or Resale

<u>Tattoos/Leg Band</u>: For market animals, an identifying tattoo or leg band must be placed on or attached to the animal prior to arriving at the fair and must always be on the animal. Failure to comply may result in sale checks, premiums and/or awards being withheld.

<u>ID Check:</u> Tattoos and leg bands may be checked ringside to verify animals.

<u>Transporting:</u> Each exhibitor is responsible for providing their own box to transport their rabbits or poultry to and from the auction ring.

# DAIRY HEIFER REPLACEMENT PROGRAM & SALE

Purpose of the program and sale is to provide 4-H and FFA members an opportunity to:

- Learn how to select a dairy heifer (heifer calf) that has the potential of being a good-producing cow.
- Learn how to raise good quality dairy animals, demonstrating approved management principles.
- Offer for sale a top-quality dairy Heifer Replacement at the conclusion of the program if they desire.
- Give non-dairy farm members an opportunity to gain valuable experience in dairy husbandry.
- Learn how to present and market a dairy Heifer Replacement.

#### HEIFER REPLACEMENT SALE

The Merced County Fair Dairy Heifer Replacement Sale will be held on Friday, June 6<sup>th</sup> at 7:30 p.m.

- The following are acceptable ways to pay for a Heifer Replacement Purchase: CASH, CHECK, VISA, and MASTERCARD or DISCOVER.
- 2. Auction accounts are due and payable within 30 days of billing.
- 3. Buyers with outstanding accounts as of September 30, 2024, will not be eligible to purchase at the 2025 auction.
- 4. There is a 7% commission that will be deducted from all sale checks. The commission will be held in a restricted account as CDFA requires to cover bad debts and used for capital improvements to benefit the livestock program. These funds can't be donated to any charity or special donation as that would be considered a gift of public funds
- 5. ALL SALES ARE FINAL! Removal of a heifer from the Fairgrounds constitutes acceptance by the buyer.
- 6. To be recognized at the auction block and announced that an Exhibitor is donating their auction proceeds, the Exhibitor must notify the Fair upon submitting their Entry by the entry closing deadline date. All net proceeds (100%), after deduction of the auction commission and fees, must be donated to the Exhibitor's charity of choice or special donation. Under no circumstances will the auctioneers announce any donation less than 100% net proceeds at the auction block. An Exhibitor may choose to donate less than 100%. However, it will be considered a "private" donation and not announced.
- Alcohol may <u>not</u> be given as part of any buyer's gift as it conflicts with the 35<sup>th</sup> District Agricultural Association's Alcohol Management Policy of "no outside alcohol may be brought onto the grounds".

#### **ELIGIBILITY**

The program will be available to all 4-H and FFA members and qualified independent exhibitors residing within Merced County. The heifer must be part of a bona fide dairy project, which means any member carrying this project must be enrolled in a 4-H Dairy project, be a member of a FFA Chapter, or be a qualified independent exhibitor. Exhibitor must use show halters and proper 4-H and FFA uniforms are required as stated in the handbook.

Applications into the program are due in the fair office no later than February 7<sup>th</sup> at 5:00 p.m.

#### OTHER INFORMATION

If, for unforeseen reasons, the project is terminated before the sale (to be held as a part of the 2025 livestock show), the original owner must be given the first opportunity to purchase the heifer.

- There will be absolutely no substitutions of animals after the application deadline as stated in the heifer requirements.
- Any missing documents will be accepted with a late penalty fee of \$25 to be paid upon delivery of materials. Materials will only be accepted one week after the Heifer committee has reviewed the submitted documents. Failure to furnish documents will result in the disqualification of the heifer.
- 3. Any replacement heifer that calves before Monday, June 2<sup>nd,</sup> will not be allowed to be sold through the sale at the Merced County Fair. The heifer may be transferred and exhibited in the appropriate class.
- 4. Members are encouraged to insure their animals.
- 5. No premium money will be paid on any animal that is sold through the auction.
- 6. On Monday, June 2<sup>nd</sup>, at 2:00 p.m. All Heifers selling through the 2025 Sale will:
  - a. Undergo a thorough veterinary health check for pregnancy confirmation, udder soundness, Brucellosis vaccination tattoo verification and a check for general health and soundness. During this check any heifer found:
    - Without a valid, legible Brucellosis tattoo
    - Open, or not bred to calf within 90 days of the auction:
    - Blind in one or more quarters;
    - For the other detrimental health reasons as determined by the veterinarian(s) will be disqualified from the sale. Any heifer found without a valid, legible Brucellosis tattoo will be sent home immediately. Other heifers on recommendation of the veterinarian(s) may be sent home. The decision of the veterinarian will be final (Refer to State Rule X. 5).
  - b. Have the State Brand Inspector perform a brand inspection on each heifer.
  - Have a picture review verification of all heifers by members of the Merced County Fair Dairy Heifer Replacement Committee

# LARGE ANIMAL SHOWMANSHIP

Animals shown in showmanship must be owned by the exhibitor and entered by the exhibitor in an appropriate market or breeding class. Those winners who are eligible to move up to the 4-H Senior and FFA Advanced Showmanship Divisions must use the same animal they qualified with.

Late entries for showmanship in the Beef, Boer Goat, Dairy Cattle, Sheep, and Swine classes will be allowed with a \$20 late entry fee by Thursday, May 22, 2025.

The judges will give a score of 1 through 7.

In the event of a tie, a Quiz Bowl will be held, with seven questions asked, one for each species. Should there be another tie, the Judges will continue the Quiz Bowl until they are able to declare a winner.



- Open to Junior exhibitors residing in a Merced, Madera, Mariposa & Stanislaus County School Districts. Exhibitors are to use their age as of December 31, 2024 when determining which class to enter.
- Entries are due on or before Thursday, May 1<sup>st</sup>, and must be made in the online portal, which can be found at www.mercedcountyfair.com.
- POST ENTRIES: There will be NO post entries allowed.
- A \$14 drug fee per horse is required.
- Refunds of entry fee over-payments under \$10 will not be made.
- See State Rules Section XI, for Ownership and Lease requirements.
- Exhibitors are responsible for knowing all rules and regulations pertaining to the horse show, including their eligibility for classes entered. Rules prescribed by the West Coast Horse Show Rule Book shall apply provided they do not conflict with any of the rules and regulations prescribed by the Department of Food and Agriculture or the Merced County Fair Horse Show Rules.
- Exhibitors will be ready to show when class is called; if the exhibitor is not inside the arena by 3<sup>rd</sup> call, they will be scratched without a refund.
- Show management reserves the right to combine or split classes as deemed necessary.
- At the discretion of Horse Show Officials, any horse that is determined to be unsafe, unruly, or unsound, may be excused from participation. No Stallions will be permitted.
- It is mandatory for all riders, regardless of discipline, to wear a properly fitted equestrian helmet that meets ASTM/SEI approval with a secured chin harness properly fastened at all times while mounted. Safe and proper equipment needs to be used. If there is a concern, the judge will make the final decision.
- Walk jog/trot exhibitors are limited to entries in walk jog/trot classes only, with the exception of classes 2 & 3. Walk jog/trot exhibitors will be eligible to compete for one year only (except students with disabilities will be allowed to continue to show in walk jog/trot classes under

- the discretion of the superintendent.) If two or more years, not eligible for high point award.
- Lead line: The age requirement is 5 to 8 years old, and not eligible for any other horse show event. No Entry Fees, No cash awards. Participation ribbons only. Must be able to sit on a horse independently and have feet in stirrups.
- Must ride independently unless ruled by the judge. Walk Only (Special Needs): Will show with lead line contestants, eligible for placings and awards, entry fee charged, and entry is at the discretion of show management
- HORSE SHOW ATTIRE: 4-H and FFA uniforms, formal or informal, are acceptable attire in all classes provided a long sleeve shirt with collar is worn. Uniforms are required for showmanship. See Local Livestock Rules for uniform requirements.
- WESTERN ATTIRE: Exhibitors must wear appropriate western attire, including longsleeved shirt with collar and appropriate western boots. Spurs and chaps are optional.
- ENGLISH ATTIRE: Breeched or jodhpurs of conservative colors are to be worn. Boots or jodhpur or hunt style are mandatory. The top portion of the uniform can be their 4-H or FFA uniform. Long-sleeved shirt or blouse, with stock, tie or choker are to be worn. Vests, spurs, and gloves are optional. Coats of traditional Hunting Style and conservative color or Saddle Seat Style and color are optional.

- 1. ONLINE ENTRY IS DUE BY MAY 1, 2025 at 11:59 PM.
- Rabbits will be entered, shown and judged in proper division and class for breed, age and sex. At the time of entry, animals not identified by sex, ear tattoo and breed will be considered deficient and ineligible to show.
- 3. No tattooing will be permitted on the fairgrounds. All Rabbits must be tattooed prior to arriving at the fair.
- Rabbits found to be in ill health will be refused from the show by the show committee and MUST be removed from the fairgrounds.
- 5. Exhibitors limited to FOUR (4) entries per class in divisions where breed is specified. In the "All Other Breeds" divisions, Rabbits must be entered, shown and judged in the proper division and class for breed, variety, age and sex. Fair Management will break the divisions. (NOTE: Per State Rule IV (6), "no exhibitor shall receive more than two cash awards in any one class using American judging system. exhibitor earns more than two awards in a class, the exhibitor will receive the two highest cash awards, and the lesser cash awards will be moved down the placings to other exhibitors; ribbons will be awarded as placed."). One entry per exhibitor in the Meat Pen division. Limit of 15 entries per exhibitor excluding showmanship. Meat Pen counted as one entry.

#### 1. ENTRIES DUE ON OR BEFORE MAY 1ST.

- Check-in starts at 7 a.m. FRIDAY, JUNE 6<sup>th</sup>. Judging begins at 9 a.m. Birds will be released after showmanship.
- 3. Birds found in ill health will be refused from the show by the poultry inspector and MUST be removed from the fairgrounds.
- All standard bred poultry will be judged by comparison to the latest edition of the "American Poultry Association Standard Of Perfection" and "Bantam Standard". All non-

- standard and utility fowl will be judged on condition and suitability to utility.
- Exhibitors limited to four entries per class, however, State Rule 6, Section IV, regarding payment of cash awards will apply.
- 6. Once cleared through health inspection birds will be placed in assigned cages according to entry tags.
- BANDS ARE REQUIRED on all birds upon arrival, except Geese, Ducks and Turkeys. All Geese, Ducks and Turkeys must have bands on cages. Birds must be banded before inspection.
- Exhibitors are required to be in uniform and stay at ringside for the duration of the show. Exhibitors shall not state ownership of any birds to the judge.
- Companion birds must be one to a cage to be judged.
- 10. All birds are entered at the owner's risk. The fair, employees, judges and show personnel are not responsible in any way for loss, injury or death of entries. All reasonable precautions will be taken to ensure their safety.
  - 11. All birds must be owned by the exhibitor a minimum of 30 days.
  - 12. Avian must be owned by and in the care of the Exhibitor and shown by the Exhibitor
  - 13. Best in Division winners are eligible for State Fair.
