Only stock trucks requiring use of electricity are charged \$150.00. If your stock truck is used just for supplies and there is no need for electricity, it can be parked up against the chain link fence in the Concessions lot, which backs up to the carnival area, at no charge. However, that vehicle does need to be listed above. An RV permit will be provided for that vehicle as well.

We have very few 50AMPS available for RVs, and these are reserved for large bunkhouses. If you need more than 30AMPS, please check with the fair office prior to hooking up your RV. RV spaces are assigned by number and you must use only the hook ups closest to your RV space.

The \$150 weekly fee covers arrival no earlier than 8:00 AM, Monday, June 2nd and departure no later than 5:00 pm, Monday, June 9th. If you must arrive/depart before the specified dates, prior approval is needed and additional fees may be charged.

**Each unit is assigned a specific location for the week of the fair. YOU MUST CHECK INTO OFFICE FOR SPACE NUMBER PRIOR TO UNHOOKING UNIT.** Failure to do so may result in unit being towed at owner's expense. Only one RV and one stock truck per concessionaire in the Concessions lot. Those vehicles will have RV permits assigned, which must be placed in the front window of the vehicle and visible to parking attendants. Vehicles with delivery passes are only allowed into the Concessions lot until 4:00 pm, Wednesday/Thursday/Friday and up to 2:00 pm, Saturday/Sunday. All vehicles with only delivery passes must exit the Concessions lot daily by the designated time or will be subject to towing. Prior to 4:00pm Wed/Thur/Fri, and 2:00pm Sat/Sun, those vehicles can drive through the gate at the red barn and park in the 11<sup>th</sup> Street lot at no charge.

If you need any additional spaces for vehicles, you must register that vehicle in the fair office and we will try to accommodate and provide you with one additional RV parking permit for one additional vehicle. This will allow that vehicle in/out access in that lot.
